1	The umpires notify the teams when there are 30 seconds and 10 seconds before the start of each quarter/half.	TRUE
2	The centre pass is taken alternately by the Centre of each team.	TRUE
3	At a stoppage for an emergency or other circumstances the umpires decide whether the players leave the court or not.	TRUE
4	If two players from the same team gain possession of the ball in quick succession, the first player must remove their hands or it is deemed a short pass.	FALSE
5	From a two footed landing, a player may step with one foot in any direction one or more times while pivoting on the other foot.	TRUE
6	An opposing player may attempt to defend a player who has possession of the ball, provided she is 0.9 m (3 ft) from both feet of the player with the ball.	FALSE
7	A player who is within 0.9 m (3 ft) of an opponent (measured on the ground) without the ball may keep arms outstretched to mark an opponent.	FALSE

3. The umpire notices there is blood on a player and neither team has called for time. What should the umpire do?		
A	Ignore the blood and let play continue.	
B	Advise the player to call for time.	
C	Take time and the player concerned must leave the court for treatment.	X

4. Two players from the Blue team gain possession of the ball in quick succession and the first player removes her hands from the ball. What action should the umpire take?		
A	No infringement and play continues.	
B	Penalise the Blue team for short pass and award a free pass to Red team.	
C	Take a toss-up.	X

5. The umpire has already spoken to the Blue WD for repeatedly going offside in the Goal Circle. The Blue WD does not change her play and continues to go offside into the goal circle.		
A	Penalty pass to the Red team from outside the goal circle.	
B	Free pass to the Red team and the Blue WD is suspended.
